All booths are 10 x 10. Booths 1 - 14 are \$725 per booth for MFA Members and booths 15 - 33 are \$625 per booth. **Electricity and/or telephone service need to be ordered on the form that will be provided by Lake Terrace Convention Center.** Exhibitor set up may begin at 10:00 a.m. on October 13. Please plan to have your exhibit setup before 6:00 p.m. on Wednesday, October 13. **MFA members and meeting attendees will join exhibitors at Lake Terrace Convention Center for the Welcome Reception.** Thursday morning, we will begin with continental breakfast at 7:30. Friday morning from 7:30 to 9:00 a.m. will also include coffee with exhibitors.

For safety reasons, set up will not be allowed after 6:00 p.m. Wednesday. Break-down can begin any time after 9 a.m. on Friday morning.
