6:30 p.m. Monday, Feb. 5, 2007, Southeast District

Meeting location: MFC district office, Wiggins

Directions: The Southeast District Office is located at 1528 S. Azalea Drive (Hwy 49 South). This is approximately 1.5 miles south of the Hwy 26/Hwy 49 intersection.

6:30 p.m. Tuesday, Feb. 6, 2007, Southcentral District

Meeting location: Old Post Office, Bay Springs

Directions: From the intersection of Highway 15 & 18, take hwy. 18 east, cross railroad tracts, go up the hill and when you reach the three way stop, the Old Post office is on your left (North side of the road).

6:30 p.m. Thursday, Feb. 8, 2007, Northeast District

Meeting location: Northeast Miss Research & Extension Center, Verona

Directions: Northeast Mississippi Research and Extension Center, 5421 Hwy. 145 South, Verona, MS 38879. From Tupelo, take Hwy 45 south to the Brewer Rd exit, go west on Brewer Road to Hwy 145 about 1 mile. Go north on Hwy 145 about 1 mile. Meeting location: MFC district office, Elliott

Directions: South of Grenada on Hwy 51, 5.4 miles from the intersection of Hwy. 8 and 51. North of Elliott 0.6 miles from the intersection of Nat Trout Road (Camp McCain Road) and Hwy. 51. Elliott is exit 199 on Interstate 55. There is an MFC sign out front and a 400 foot radio tower on the property.

Directions: From I-55, take the second Brookhaven exit by Home Depot. Go underneath the interstate heading east. You will see Wal-Mart and other businesses.
